

Get your India visa as easy as possible!

Germany

Business

- 1 fully filled and original signed visa application form: <https://indianvisaonline.gov.in/>
The application must be signed on page 1 below photo and on page 2.
Please check by which consulate you have to apply the visa. At the end is the overview, which consulate is responsible for which German state.
- Original, actual passport, valid for at least six months beyond visa expiry date and with at least 2 opposite free pages
- 2 photographs in color with white background; 5x5 cm
- Invitation letter in English, on company letterhead, stamped and signed.
The letter must specify:
 - ✓ Name from the traveling person and passport details
 - ✓ Reason for the trip (business meetings or business discussion)
 - ✓ Entry and exit dates and validity (for example 1 year with multiple entries)
 - ✓ Planned place of stayThe letter must be addressed to the respective consulate, see the overview at the end.
- A letter in English of introduction from the applicant's employer in Germany or Switzerland, stamped and signed. The letter must specify:
 - ✓ Name from the traveling person and passport details
 - ✓ Reason for the trip
 - ✓ Entry and exit dates and validity (for example 1 year with multiple entries)
 - ✓ Detailed information on the activity of the applicant (according the invitation letter)
 - ✓ Complete address and telephone number of the Indian business partner
 - ✓ Coverage of the whole cost during the tripThe letter must be addressed to the respective consulate, see the overview at the end.
- If necessary, a copy of the applicant's residence permit valid for Germany. As well the copy of residence registration form/card by a German local authority. For EU citizens, the copy of the residence registration form/card is sufficient.

The consulate to which the visa is to be applied depends on the competence of the respective consulate:

Embassy of India, Berlin: Berlin, Brandenburg, Mecklenburg-Vorpommern, Sachsen, Sachsen-Anhalt, Thüringen

Consulate General of India, München: Baden-Württemberg, Bayern

Consulate General of India, Hamburg: Bremen, Hamburg, Niedersachsen, Schleswig-Holstein

Consulate General of India, Frankfurt: Hessen, Nordrhein-Westfalen, Rheinland-Pfalz, Saarland
